



# IA PROGRESS REPORT 25/08/09

There are 14 months left to THE AUDIT – or in 2010 speak 417 days. The various processes planned for the IA are progressing well. There has been slippage in some areas and gains in others. Attention has been on developing the IQMS further and there has been extensive planning, development and implementation with this regards – all activities that are required for the report.

The audit was deliberately started early. We are mindful of the extensive workload sitting with senior and Executive Management and have not taken a hard stance, yet. Evidence and information is being gathered and as far as we are involved in activities, we are updating information and trying to keep abreast of the extensive changes moving through the institution. This in itself is no mean task and we will have to take a point at which we report on the CPUT situation as it stands – the end of this year is suggested. Increasing involvement, pressure and tension is better left to next year. It is going to be a long 10 months.

The initial visit of the HEQC to CPUT takes place on 19<sup>th</sup> October, 2009. This meeting will be with Executive Management and Quality management.
